Terms and Conditions

1. Entry into the HAWAIIAN 2020 WOMENS WALK FOR CANCER Dollar Match Day Promotion (“Promotion”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. The Promoter in all States and Territories is the Harry Perkins Institute of Medical Research 6 Verdun Street, Nedlands WA 6009 (ABN 16 823 190 402) (the Promoter).
3. Entries for the Promotion commence on 08:00 Tuesday, 30 June 2020 and close at 11:59hrs Tuesday, 30 June 2020 (“Promotion Period”) unless the overall value \$20,000.00 is reached prior.
4. Entry is open to registered HAWAIIAN 2020 WOMENS WALK FOR CANCER participants (“Entrants”).
5. Entrants must receive a donation via their personal fundraising page during the Promotion Period. Donations can be made by searching a name via the HAWAIIAN WOMENS WALK FOR CANCER website <https://www.walkforwomenscancer.org.au/>
6. The Total Promotion Pool is valued at \$20,000.00 (Total Promotion Pool).
7. The Entrant’s donations received during the Promotion Period will receive a dollar match from WOMENS WALK FOR CANCER, up to the value of each donation to a maximum of \$500 per donation towards their fundraising goal (Prize), provided that the Total Promotion Pool is not exceeded.
8. Calculations will be conducted at time of donation and then verified on 20 July 2020 at the Harry Perkins Institute of Medical Research, 6 Verdun Street, Nedlands WA 6009
9. The WOMENS WALK FOR CANCER dollar match, not exceeding the Total Promotion Pool in aggregate, will be visible on the valid Entrants fundraising page at the time the donation is made.
10. If for any reason this competition is not capable of being conducted by the Promoters as intended, whether because of computer virus, mobile phone failure, bugs, tampering, unauthorised intervention, fraud, technical failures, or any other cause beyond the reasonable control of the Promoter which in the Promoters’ opinion affects the administration of the competition, security, fairness or integrity, the Promoters may in their sole discretion, cancel, modify or suspend the competition, subject to the approval of the Department of Local Government, Sport and Cultural industries, Racing, gaming and Liquor in Western Australia as may be required.
